Board suggested to offer 3 years BPA in Theatre Arts and BPA in Vocal Music separately. Board suggested to prepare 5 years (3 years BPA and 2 Years MPA) syllabus for both the discipline separately and recommended to form a "Syllabus Committee" with 4 external experts for Theatre Arts and 4 external experts for Vocal Music. Since it is a new phenomenon with multiple entries and exits, a specialized syllabus needs to be prepared in accordance with the NEP 2020. |

Theatre Faculty cannot teach a single paper of music discipline and Music Faculty cannot teach a single paper of theatre discipline. |
