- Having accepted the terms and conditions of Offer of Appointment Ref. No.: CUJ/R.C./137/2023/867 dated 15th March, 2024, the Vice Chancellor is pleased to accept joining of Dr. Rajesh Kumar Mondal as Professor (under SC category) Department of Life Science, Central University of Jharkhand w.e.f. 21.05.2024 (afternoon) on the following terms & conditions.
 - (a) The appointment is on probation for a period of one year in the first instance from the date of joining which may be extended for another period of one year.
 - (b) The appointment may be terminated during the period of probation by giving one month notice without assigning any reason by the either side.
 - (c) The University, however, reserves the right to terminate his services forthwith or before the expiry of the stipulated period of notice by making payment of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
 - (d) The confirmation in the service is subject to the satisfactory performance on research, teaching/learning and student feedback.
 - (e) The incumbent has to perform such duties as may be assigned to him by the Head of the Department and Competent Authority from time to time.
 - (f) The services will be governed by Act, Statutes, Ordinances, Rules and Regulations, of the University which are in force at present and as may be amended/modified from time to time.
 - (g) The services will also be governed by CCS (Conduct) Rules, 1964 & CCS (CCA) Rules, 1965 of the Government of India as amended from time to time.
- The joining is provisional, subject to verification/authentication of relevant documents submitted by him as per appointment/advertisement terms & conditions.
- 3. All other terms & Conditions of offer of appointment/advertisement shall be applicable.
- 4. This is issued with the approval of the Hon'ble Vice Chancellor.
