## कार्यालय आदेश / Office Order

- Consequent upon recommendation of selection committee on 18<sup>th</sup> October, 2023 and the approval accorded by the Executive Council in its 45<sup>th</sup> meeting held on 26.12.2023, the Vice Chancellor is pleased to accept joining of Dr. Bikash Ranjan Parida as Associate Professor (under UR category) Department of Geoinformatics, Central University of Jharkhand w.e.f. 09.01.2024 forenoon on the following terms & conditions.
  - (a) The appointment shall be on probation for a period of one year in the first instance from the date of joining which may be extended for another period of one year.
  - (b) The appointment may be terminated during the period of probation by giving one month notice without assigning any reason by the either side.
  - (c) The University, however, reserves the right to terminate his services forthwith or before the expiry of the stipulated period of notice by making payment of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
  - (d) The confirmation in the service is subject to the satisfactory performance on research, teaching/learning and student feedback.
  - (e) The incumbent has to perform such duties as may be assigned to him by the Head of the Department and Competent Authority from time to time.
  - (f) The services of the incumbent will be governed by Act, Statutes, Ordinances, Rules and Regulations, of the University which are in force at present and as may be framed/amended/modified from time to time.
  - (g) The services of the incumbent will also be governed by CCS (Conduct) Rules, 1964 & CCS (CCA) Rules, 1965 of the Government of India as amended from time to time.
- 2. The joining is provisional, subject to verification/authentication of relevant documents submitted by him as per appointment/advertisement terms & conditions.
- 3. All other terms & Conditions of offer of appointment/advertisement shall be applicable.
- 4. This is issued with the approval of the Hon'ble Vice Chancellor.
