ABOUT THE CONFERENCE

The vision of Viksit Bharat 2047 envisages India as a developed, inclusive, and self-reliant nation by the centenary of Independence. Central to this vision is the upliftment of marginalised and historically excluded communities, particularly tribal populations who are integral to India's cultural heritage, ecological sustainability, and socio-economic resilience. Jharkhand, home to one of the largest concentrations of tribal communities in India, presents a striking paradox: rich natural resources coexist with persistent poverty, low human development indicators, health disparities, and fragile livelihoods. Despite multiple policy interventions, development outcomes remain uneven due to fragmented implementation, limited community participation, and insufficient integration of indigenous knowledge systems.

This International Conference seeks to provide a global, interdisciplinary, and policy-oriented platform to examine tribal upliftment in Jharkhand through the interconnected dimensions of policy, culture, health, education, livelihoods, forest rights, and sustainable development. The conference foregrounds tribal communities as active agents of development, rather than passive beneficiaries, and promotes culturally grounded, participatory, and evidence-based approaches aligned with national priorities and the UN Sustainable Development Goals (SDGs).

INVITATION FOR PAPER

Papers are invited on the indicated themes. Prospective paper presenters are requested to adhere to the paper submission guidelines.

GUIDELINES FOR PAPER SUBMISSION:

- Originality: The papers must be original, unpublished, and not under consideration for publication elsewhere.
- Format: Papers should be written in English only, in MS Word (.doc/.docx) using Times New Roman, 12 pt, 1.15 line spacing. The length of the paper should be between 2,000–5,000 words, including the abstract but excluding references. All references should follow APA 7th edition format.
- Abstract: Each paper must be accompanied by an abstract of 250–300 words, highlighting the objectives, methodology, major findings, and implications of the study. The abstract should also include 3–6 keywords.
- Author Details: A maximum of three authors is allowed per paper. All authors are required to register for the seminar separately.
- Cover Page: The cover page must include the title of the paper, name(s) of the author(s), designation, institutional affiliation, email ID, and contact number. The presenting author's name should be underlined.
- Presentation: Selected papers must be presented during the seminar using PowerPoint, within a presentation time of 8–10 minutes.
- Plagiarism Alert: Papers must not be plagiarised. Authors are required to submit a self-declaration of originality of the papers, and when required
- Publication: High-quality papers selected by the review committee will be published in an ISBN book volume or a peer-reviewed journal. The decision of the review committee regarding publication will be final.

CALL FOR PAPERS

- The Conference invites original and unpublished contributions from academicians, researchers, policymakers, development practitioners, civil society members, and doctoral scholars.
- Submissions may adopt empirical, theoretical, comparative, or practice-oriented approaches, and should clearly demonstrate academic rigor, interdisciplinary insight, and policy relevance, particularly in the context of tribal development and sustainable futures.
- Based on peer review and thematic relevance, selected papers will be considered for publication in an edited volume or a peer-reviewed journal.

INDICATIVE SUB-THEMES

The following sub-themes are indicative and not exhaustive. Contributors are encouraged to submit papers broadly aligned with the conference theme, including related, emerging, and interdisciplinary areas that engage with issues of tribal upliftment, policy, culture, governance, and sustainable development.

Submissions may address, but are not limited to, the following areas:

- Demographic dynamics and social mobility among tribal communities
- Tribal socio-economic status: challenges and development imperatives
- Indigenous knowledge systems, traditional medicine, and healing practices
- Tribal health disparities and culturally attuned healthcare interventions
- Forest Rights Act (FRA), Community Forest Resources (CFR), and livelihoods
- PESA and local self-governance in tribal regions
- Cultural heritage, oral traditions, folk arts, and identity
- Indigenous disaster resilience and climate knowledge
- Impact of modernisation on tribal culture and livelihoods
- Gender, tribal women, and community leadership
- Education, language, and Eklavya Model Residential Schools (EMRS)
- Climate change, biodiversity conservation, and sustainability
- Comparative perspectives on tribal development (India and globally)

OBJECTIVES OF THE CONFERENCE

- To critically examine governance frameworks and public policies impacting tribal development in Jharkhand
- To integrate indigenous knowledge systems with national and state-level development strategies
- To analyse socio-economic, demographic, health, and educational challenges of tribal and PVTG communities
- To explore culturally sensitive and participatory models of sustainable development
- To align tribal upliftment strategies with Viksit Bharat 2047 and the UN SDGs.
- To generate evidence-based policy recommendations and development frameworks

CONCEPT NOTE

As India advances the Viksit Bharat @2047 agenda, the inclusion of tribal communities is not charity, but a strategy for sustainable development. Jharkhand, home to 26% tribal population (Census 2011), has a paradox of resource wealth coexisting with persistent poverty, low literacy (~59%), and health disparities. This paradox demands a new paradigm: development with tribal leadership, not over it. As the title of the proposed international conference envisages, tribal communities are active architects and not passive beneficiaries. Their sustainable lifestyles, ecological knowledge, indigenous practices and cultural assets are national strengths to be documented, scaled, and leveraged for inclusive and sustainable social and economic development. Tribal communities are the original custodians of India's forests, rivers, and ancient wisdom. Their traditional practices, shifting cultivation, herbal medicine, and forest-based livelihoods, demonstrate a deep interlinkage with sustainable development. In the context of Viksit Bharat, it is imperative to:

- Establish "Tribal Knowledge Centres" in every block where elders teach ethno-botany, shifting cultivation, and languages; digitise oral histories via AI-enabled multilingual archives.
- Launch women-led forest product cooperatives with direct e-market linkage (e.g., lac, mahua, tendu); target ₹500 crore export potential by 2030.
- Scale "Tribal Fitness & Herbal Wellness Centres"; integrate Santhali yoga, Baiga herbal protocols into Ayushman Bharat; pilot Tribal TB Mukt Panchayat 2.0.
- Set up District-Level Tribal Art Hubs; train 10,000 youth annually in Warli, Sohrai, Jadopatia; link to GI-tagged handicraft exports.
- Launch "Adivasi Awaz" community radio in 5 tribal languages; broadcast weather, market prices, and FRA rights updates.

Recognise tribes as "Forest Rights Guardians" under FRA 2006; incentivize Community Forest Resource (CFR) management with carbon credits

The vision of Viksit Bharat 2047 cannot be realised without the active participation and empowerment of tribal communities. As custodians of India's rich natural resources and traditional knowledge, tribal populations play a vital and irreplaceable role in the nation's social, cultural, ecological, and economic development. Recognising, respecting, and partnering with their contributions is a strategic imperative for sustainable and equitable growth. This conference provides a platform for national and international academicians, policymakers, and community leaders to discuss, debate, and devise actionable strategies. It aligns tribal upliftment with UN SDGs, with a specific focus on:

- SDG 1 (No Poverty): CFR-based NTFP value chains
- SDG 2 (Zero Hunger): Seed banks of 50+ indigenous crops
- SDG 3 (Health): 100 mobile herbal clinics
- SDG 4 (Education): 500 EMR Schools with tribal language medium
- SDG 5 (Gender): 70% women in forest cooperatives
- SDG 13 (Climate Action)
- SDG 15 (Life on Land): 1 lakh hectares under CFR management

EXPECTED OUTCOMES OF THE CONFERENCE

Expected outcomes of the conference includes:-

- (i) evidence-based policy recommendations and framework,
- (ii) identification of key domains and indicators for tribal-centric development, addressing critical issues underlying environmental protection and climate change,
- (iii) cross-sectoral collaboration models; and
- (iv) reviewing issues pertaining to tribal in Jharkhand compared to other parts of India and elsewhere in the world. More specifically, the conference will produce the following deliverables:

- A Policy Brief for Jharkhand's Tribal Sub-Plan 2.0.
- Scoping the feasibility of a Jharkhand Tribal Development Index (JTDI) Dashboard (open-source, real-time).
- Areas for multi-sectoral MoUs for pilot projects (2026-28).
- A Global Declaration on Tribal-Led Sustainability.
- Bring out a socio-economic and cultural profile in detail among the tribal populations of Jharkhand.
- Identification of structural and policy-level challenges to tribal upliftment.
- Evidence-based policy recommendations on participatory and culturally sensitive approaches.
- A conceptual model integrating Viksit Bharat 2047 principles with tribal development indicators.

International conference on the theme: "Tribal Upliftment in Jharkhand: Integrating Policy, Culture, and Sustainable Development under Viksit Bharat 2047", thus, targets to provide a platform to national and international academicians, policymakers, community leaders and scholars to discuss, debate and devise actionable strategies for attaining integrated growth and sustainable development to realise the Sustainable Development Goals as enunciated internationally. The conference aims to align issues related to tribal upliftment through development strategies with the UN SDGs, focusing on areas such as poverty eradication, security, health and well-being, quality education and gender equality; cleaner energies, decent work and economic growth; innovations, industries and infrastructure, reducing inequalities, responsible consumption and production; biodiversity conservation, peace, justice and stronger institutions; and partnerships for achieving these goals.
