There was a fire incident in UG Boys Hostel at Manatu Campus on 21.07.2025. Initial facts and figures was sought from DSW, Chairman-Proctorial Board and Security Officer. Subsequently, a Committee vide Office Order ref. CUJ/RG/CMT/12/2025/139 dated 23.07.2025 was constituted to thoroughly investigate into the details of the above incident. The said report of the said Committee was forwarded to the Chairman-Proctorial Board for further examination and recommendation as per CUJ Ordinance.
