I am writing this to highlight the matter related to implementation of applicable modules of SAMARTH portal across Central Universities from academic year 2024-25.

- 2. SAMARTH Portal provides a gamut of digital tools that are integrated in an online platform for efficient resource planning and management, process and service improvement. and good governance in higher education.
- This portal will help institutions to streamline their repository of records starting from admission details to examination, employee data, payroll and administrative information amongst others.
- 4. The multi-pronged benefits of this portal have been stressed through various Virtual Conference Meetings conducted in this regard wherein Central Universities have been repeatedly requested to complete the updation of employee data/profiles. Now, all Central Universities are requested to submit a status/compliance report regarding 100% onboarding and updation of profiles of all the employees of respective CUs. It may also be apprised as to whether the complete employee module (inclusive of all matrices) has been made fully functional in the respective CUs and any further modification (amendment, deletion, addition etc.) in the employee service data is being done through SAMARTH portal only. All Central Universities are expected to send the status/compliance report to this Ministry latest by 15<sup>th</sup> May, 2024.
